HT STRATEGIC REPORT 52

52a **Overall Effectiveness**

- Assemblies have been focussing on future opportunities
- Middle leaders continue to review the curriculum, evaluate gaps and work with subject teams to assess
- Attendance remains a key focus with PA on the rise
- Diana Award and Duke of Edinburgh Award launched this term
- A number of staff have begun NPQ (National Professional Qualification) through Vantage Teaching School
- Tech subjects recovery sessions held over the Easter break

Q: (AB) How do you evaluate the identified gaps?

SK: It's an ongoing piece of work. Where possible, the curriculum has been re-sequenced to enable re-teaching of elements taught during lockdown. We have identified where the students were lacking knowledge and built it back into the curriculum. The Technology subjects posed a problem during lockdown as they cannot be taught remotely but we have quickly identified those gaps and are filling them

C: (AB) It's useful to see the national data. It's good that Wolfreton has good attendance and the behaviour is above national

C: (SK) Attendance is good and also above national but it's not where we want it to be. PA remains a concern as the students have developed 'out of school' habits. A temporary staff

member is working on data capture for absence and this frees up the Attendance Officer to work more with families and children

Q: (DG) Were the D&T recovery sessions well attended by DA students?

SK: They were variable but better than anticipated

Q: (SM) 46 lesson reviews have been conducted so far. Is this lower than previous terms?

SK: It is lower but we have been conducting more informal lesson drop-ins

Q: (SM) Are Years 11 & 13 feeling resilient or concerned?

SK: They are managing well under the circumstances but it's also important to note that feeling anxious around exam time is normal in any circumstance

52b **Quality of Education Summary**

Curriculum

Guided Choices

- Year 9 students have been undergoing the Guided Choices Programme to select their KS4 courses
- All students study the core curriculum of English Literature, English Language, Maths, Science, RE, PSHE, PE & 1 Humanities plus 3 further choices from a wider selection
- Tutors and PSHE staff have supported with individual gueries
- Individual discussions took place during Yr9 parents evening
- Lessons reviews have recommenced and 46 were completed in the second Autumn half term
- Teaching & Learning continues to be of a good standard overall
- Learning Walks have become more common place

Professional Development

- The 2021 CPDL programme is ongoing. Areas include:
 - Teaching to the Top
 - Retrieval Practice
 - Closing the Reading Gap
 - Sharing of Good Practice
- Feedback from the January training day was positive
- Reading strategy has 3 strands: reading for pleasure, reading for purpose and reading recovery

Standards

- From a cohort of 264, 133 are High Ability, 118 are Middle Ability & 12 are Lower Ability. 41 students (16%) are DA. There is no KS2 data for 1 student
- P8 is -0.04, dropped -0.1 since DT1
- A8 is 48.39, down by 1.02 since DT1
- 'Strong' BASICS 9-5 46%, up by 4% since DT1
- 'Standard' BASICS 9-4 68%, up by 2% since DT1
- EBacc entry is 60%
- The DA cohort remains below the national average with P8 internal gap at -0.37
- The ability on intake of DA (103.4) is lower than 'other' students (105.2)
- 29 students receiving SEN support, 6 with an EHCP & 5 are EAL
- Improving subjects include Combined Sciences. Causes for concern include Business

Q: (SM) How are you supporting EBacc?

SK: We are doing what is right for the students, not the data tables. The entry number has come down but we have external support from Yipiyap and My Tutor in place to address this

LAC Update

Currently 5 LAC on roll, all below targets

52c **Behaviour & Attitudes Summary**

- Attitude to learning in classrooms continues to be good
- Some students still feeling unsettled after lockdown, staff are working closely with them
- House points awards continue to increase
- Hot Chocolate Fridays and Film Nights still popular
- 926 Stage 4 isolations so far this academic year
- 7 FTEs in the Autumn term
- Suspensions remain below national at 4.24% (Nat 7.43% 2019/20)
- 1 student permanently excluded
- PA, although starting to reduce, is high across all cohorts. Attendance & Welfare Manager working with families who need the most support
- Attendance % shared weekly with students. This in turn creates a competitive culture to reduce absence in their groups

Q: (SM) Are you seeing any particular behaviour trends?

SK: We are below national but have seen a rise in FTEs. Causes include students struggling to settle back into the routine of a school day and returning to face-to-face learning. We also have delays with the LA and EHCP referrals

AB questioned what the data represented in the ATL tables and noted many acronyms used do not appear in the list. SK to include table key on all future reports and update the acronym list

ACTION: SK to provide key to data figures for Attitude to Learning reports going forward and update the acronym list

52d Personal Development Summary

- Students Yrs7-11 following a range of character development themes during PSHE. These include, but are not limited to Sex & Relationships, Choices, Staying Safe and Diversity & Tolerance
- Autumn term enrichment event highlights were the BBC Bitesize Careers Roadshow and Year 11 Careers Fair
- Yrs12&13 attended an Apprenticeship talk by ASK/Amazing Apprenticeships
- Careers provision continues to be strong with many visits undertaken last term
- Yrs10&11 work experience to get underway later in the summer term
- Tigers Trust, HeyMind, SMASH, Run With It & B Mindful continue to support student wellbeing

- Despite significant staffing challenges due to the pandemic, staff continue to go above and beyond for all students

- 109 & 89 on roll in Yr12 & 13 respectively including 28 DA, 12 SEND
- Progress:
 - A Level Yr12 0.07, Yr13 -0.25
 - Applied General Yr12 -0.04, Yr13 0.14
 - A Level (DA) Yr12 0.15, Yr13 -0.46
 - Applied General (DA) Yr12 -0.45, Yr13 0.03
- Curriculum adapted where necessary to address gaps in learning caused by periods of lockdown
- Faculty & subject leaders supporting students to prepare for exams
- Post-16 Steering Group continues to be a place of support and cross-Trust collaboration
- Gap between DA and non-DA stands at -0.08
- Gap between SEND and non-SEND stands at -0.42
- 5/10 subjects with lowest VA are taught offsite

Q: (SM) Are there any updates on the super curricula?

LT: We are in the phase of updating and transition. The Post-16 Steering Group has been a great addition and allows us to focus on cross-Trust marketing and the super-curricula programme. BEAMS & BEATS also feature

Q: (AP) What is the scope for delivering the offer cross-Trust?

LT: It is a work in progress as the blocking suggestion shared with Post-16 is not entirely possible. There is a lot of work to be done but it is looking positive

Q: (SM) Year 13 attendance seems low, why?

LT: We have 2 students who are carers and 1 off for medical reasons, this impacts the overall data

53 EDUCATION RECOVERY FUND

- £207 275 PP funding, £30 015 recovery funding, £25 110 School Led tutoring grant received this academic year and £28 772 carried forward from previous year
- Quality First Teaching continues with targeted support in Coaching, DEAR (Drop Everything & Read), Visualisers and development of the Teaching & Learning library
- Targeted academic support makes up for the majority of the funding
- Yipiyap tutors continue to deliver small group tuition
- · Mindfulness sessions have proved very popular
