40 MATHS PRESENTATION

Mr J Pickering (Deputy Director of Maths) shared the vision of the Maths Faculty with the LGB:

- Create: A culture of excellence – best work at all times

Clear curriculum and progression routes

Challenge: High expectations
 Each lesson as valuable as the next

- Champion: All to have opportunity, encouragement and guidance to succeed

- Years 7-9 are assessed every 6 weeks
- Tier split at 12 weeks in Year 9
- The curriculum is structured so that each area of Maths is revisited with opportunities to interweave topic areas
- Curriculum changes made to account for cohorts affected by lockdown
- Self-regulated study promoted
- Effective use of assessment seen
- 6-week intervention programmes run throughout the year
- Students taking part in intervention gained at least 1 whole grade
- Classroom intervention strategies shared at faculty briefings
- Q: (AB) Thank you for this comprehensive presentation. What would you say is your biggest challenge?
- JP: Years 7 & 8, they have lower than expected AMT scores but things are in place to improve Q: (HP) With mixed ability after 3 years, are the higher end at detriment with the lower end, so to speak?
- JP: Year 7 & 8 students are together for a full 2 years and at the Christmas break, we start to transition Year 9 into the split
- Q: (MM) Is there any analysis to see how they are affected?
- JP: Yes and we do accept some move quicker than others and the 6-weekly assessments help us move them up and down
- C: (JP) We put them in as mixed so we can assess as they are coming in with no KS2 scores
- C: (MM) It's tricky as you are dealing with covid cohorts
- C: (SK) We visited their primary schools and looked at data alongside the My Tutor work
- Q: (MM) Is there a gender difference?
- JP: We have not looked at that
- Q: (DW) DA are making progress. When will we see GCSE improve under this strategy? JP: We split DA across different classes and a lot of them are accessing the work and mix with others and it has shown a significant improvement. We are working with the achievement centre to allow them alternate ways to access homework
- Q: (DW) And GCSE? Similar to last year?
- JP: No, 7+ is back a little higher but we'll have more info in 3 weeks' time. The lower sets have fewer students and that allows for a higher level of support
- C: (LT) Sixth Form students who have not passed Grade 4 continue with GCSE. They do progress, some just take a little longer
- C: (LW) The grading has changed and they now have to work harder than last year to get Grade 4

C: (SK) I'd like to thank Lauren and Lynsey for their hard work in writing this report

Q: (AB) It's good to see predicted improvement but they are still below target. What are the key interventions to improve results?

LW: Some of them identified at the start of the year have completed My Tutor online and the next group is about to start. Each department has their own interventions

Q: (AB) 9-7 – where are we at this stage? It's a 12% target in the ADP

LW: English & Maths are at 10%, 2% away

Q: (DG) There is quite a significant improvement for the DA P8 on last year's prediction – how likely are these?

LW: They have taken away fine grades so these are more accurate than ever and are based on what we expect them to do. Some will need more intervention than others

C: (SK) It's not just subject interventions. There are also mental health and attendance for example

C: (KW) It's hard to compare the data to the ADP which states 9-4 and 9-5 but on the next page states 9-7 and 9-4

- C: (LW) This is the Trust template
- C: (DW) Priority 1 looks at 9-1 and Priority 2 looks at all
- Q: (DG) All areas of Technology are underperforming. What support methods are in place for students and staff?
- LW: A number have requested, and have been granted, extra time to work on projects and we are fully supporting the faculty
- C: (SK) We are still dealing with the negative impact lockdown had on practical subjects
- Q: (DG) What support is in place for 6th Form to reach their targets?
- LT: We have been more focussed on large cohort subjects and learning walks. We will have a better indication after the data trawl, mocks have only just finished
- C: (AP) Business Studies is not taught on site but travelling students are not reflected in the tables
- C:(LT) Heads of 6^{th} will be visiting each other's sites and dropping into lessons. We also now have sight of each other's data. That, coupled with feedback from students, allows us to spot concerns quickly

43b Attendance & Behaviour Report

- Overall attendance 01/09 31/12, 91.7%. This is 0.8% higher compared to the same time last year and 1% above national
- Attendance letters and support plans continue to be utilised
- DA attendance improving
- A total of 87 (61 students) bullying concerns logged
- 116.5 days lost to FTEs & 1 Permanent Exclusion this term
- Individual Behaviour Plans and Pastoral Support Plans put in place as enhanced strategies
- Year 7 have made an excellent start to the year with no FTEs
- Think for the Future (TFTF) launched to help support improved engagement

Q: (AB) What is Think for the Future?

LW: They are an organisation who work with schools to match them up with a mentor and they deliver a planned curriculum centred around behaviour and attendance. It's small groups and they are booked for 3 terms initially and then on a termly basis after that. Their data shows huge reductions in detentions and exclusions

Q: (AB) How does WS compare? Is the intervention right, what is the impact on Year 8? SK: We've had informal chats with other Headteachers in the Trust and identified wider challenges. Year 8 are doing a good job of being responsive and the vast majority are doing well and working well with us. Interventions change all the time, depending on need. They are fluid, not fixed

C: (MM) The punitive measure in place for Year 8 seem to be in conflict with TFTF? SK: We have had to restructure roll call to minimise movement around the building as a safety measure. They still get rewarded

Q: (MM) Is there a way to measure rewards?

SK: Specifically related to the new rewards added for meeting all expectations at the additional roll call, not at this time yet. I appreciate this new measure will not be favoured by all

Q: (TL) There is a high number of SEND suspensions, could you elaborate on this?

SK: The 2 main categories are verbal abuse of staff and persistent lesson disruptions

Q: (DG) Overall attendance is 91.7%, Trust target is 94%. What is in place for us to get to this?

SK: We are working with the DfE and attendance leads. M Carruthers is also working on an attendance strategy. Our biggest gap was having no Attendance Officer for 1 term. Keeping in contact and having conversations with parents is also important, the key element is dialogue

Q: (AB) There is a lot of red and amber, have you been realistic with expectations and the timina?

SK: The start date next to many are not a singular task, the impact indicators show a much better picture. Amber does not concern me and green are more binary with a simple yes/no to close it off

Q: (KW) Can the direction of travel be indicated?

SK: Yes, it's still on my list to provide a bullet point narrative

C: (DW) All targets have been missed in P3

SK: Yes, we are still working on that. We are looking into taking whole years groups out on visits

ACTION: Arrow indicators to be added to ADP to show direction of travel for all priorities

46 PUPIL DISADVANTAGE

- Visualisers used effectively to support the reading strategy
- Feedback machines purchased are currently undergoing a trial in Art, English & Languages
- Recovery Premium used to purchase support teaching such as Massolit, Calculators and Computer Science materials
- 4 subject recovery sessions have been funded: Art & Photography, Music, Japanese & Graphics

Q: (DG) What are you doing for those subjects Tassomai does not support? What does student feedback say?

LW: We have no formal student voice and not all will love it. For those, there are alternative means. Engagement is on the increase and the students are meeting daily goals

47 ALTERNATIVE PROVISION

- There are currently 2 students accessing AP, both have settled well
- Regular visits to APs are made by Assistant HT
- The Hub School is the sole provider for WS for AP

Q: (AP) Our only provider is the Hub School. Is there anything on the horizon for something in between Wolfreton and the Hub?

SK: We work very hard to provide strategies in school, to identify the need. There are no other registered providers in the area

C: (DW) One of the Trust strategic priorities is to look further into this as there are just no places in the East Riding or Hull
