Q: (ARM) Is the target setting at FFT for KS4 and KS5? SK: Yes, and they will look across the country for a fair scope

09 SCHOOL DEVELOPMENT PLAN

The SDP has now been RAG rated. To recap, the priorities include:

- Securing and embedding excellence in teaching and learning
- Further embed evidence informed monitoring to impact outcomes of SEND, DA &
- The design of a world-class entitlement offer for personal development and character education
- Securing a consistently strong and impactful practice post-16

Q: (KW) What is the plan for the red areas moving forward?

SK: At our first extended SLT meeting last week we all agreed we had maybe been a little too ambitious with the timelines. Red does not mean it's not happening, just that there is not enough evidence to report at this early stage. I should be able to provide a full update at the next meeting in January

Q: (TL) Is it possible to break it down further into sections so we can see the building blocks that make up the bigger picture?

SK: Action Plans sit behind the SDP. The SDP is just the summary. If we were to include every action the document would be huge

C: (KW) Maybe a one or two line commentary could be added as and when necessary

Q: (TL) I see SEND scaffolding is red. What are you doing to help those teachers and learners? RA: We are supporting them with monitoring and lesson reviews. These will allow us to see where more is support is needed and where we can make further improvements. Online training is available plus a variety of other options

Q: (KW) What are the grey areas?

SK: The grey areas mean we haven't set a date as yet

Q: (KW) Are any red areas keeping you awake at night?

SK: At this point, no. Regular meetings take place and everybody knows what they have to do to keep moving forward. Absence may start showing a negative impact

Q: (TL) I see the percentage of SEND/lowest quintile students with improved reading ages is TBC?

SK: There is a delay in ART (Access Reading Tests) across all schools

Q: (TL) Can it not be compared to last year?

SK: Last year we did NGRT and the beginning and end. In September we used Quickstart and used that data. As a Trust, we invested in Reading@TCAT and part of that was choosing ART for reading assessment so we need to wait as we need to see movement within the same testing scenario

Q: (MM) Is reading partnered with homework?

SK: Not as such but we do have the DEAR programme where each year group read the same books and we have appointed a librarian who is busy rearranging the books into genres. The cannon is also underway

Q: (TL) Did the children have any input with choosing books for the cannon?

SK: Not directly but the English leads select them to be progressively ambitious after talking to the students. Their feedback forms the selection at the end of the day

Q: (ARM) In this digital age, is the library investing in any devices?

SK: Not at this moment in time

Q: (MM) Do you promote the PP help available?

LW: Yes we do. A letter goes home to all families

11 INCLUSION UPDATE

11.1 Safeguarding Update

- 1 child currently in a Category of Concern
- 8 children currently subject to a Child in Need Plan
- 5 Operation Encompass alerts received
- All staff attended the annual safeguarding training on the first day of term
- All staff up to date with PREVENT training
- 9 children currently LAC
- Overall attendance up 1.7% compared to this time last year but still not where it needs to be
- 21 students have received FTEs

Q: (TL) There is no LGBTQ+ bullying stats in this report and I know it was high last time, why no follow-up?

MC: This is a new template and a work in progress. We all feedback to L Thompson (Director of Governance) who takes our comments onboard to improve for the next meeting Q: (HP) are the attendance figures impacted by the usual suspects or is there a wider issue? MC: This data is pre-half term and we saw a lot of term-time holidays. All were denied permission but went anyway

Q: (TL) I see suspension have increased?

MC: This is due to a variety of reasons. We have raised standards, upgraded the Behaviour Policy and a number of Year 8s are still struggling to settle after 2 years of upheaval Q: (MM) Is there restorative practice before and after suspensions? MC: Yes

Q: (MM) When it comes to bullying, do you sit both parties down to talk it through? MC: When possible, yes. Although, sometimes the animosity stops that from being an option C: (SK) It's important to reflect suspensions are not done lightly. Suspensions do not take place after an isolated sanction and there is a large amount of pastoral support involved C: (MM) With regards to the vacancies, if we as governors had sight of them sooner we could maybe reach further to try fill them

ACTION: LC to check with LT re missing LGBTQ+ & Homophobia bullying statistics for the next report

ACTION: LC to liaise with R Lane with regards to alerting governors of vacancies as and when they arise

11.2 SEND Update

- 38 students on an EHCP
- 110 receiving SEND support
- 148 on SEND register
- SEND TA recruitment remains challenging

Current interventions include, but are not limited to:

- Small group reading and spelling
- Homework support
- Speech and language lessons (via Mable)
- Maths Mates
- PSHE tailored lessons
- Break and lunch club for SEND
- Transition support

Q: (HP) SEN intake has increased. Is this due to the good reputation of WS or the larger need? RA: A bit of both really but the need is greater than ever

C: (SK) The biggest challenge we face for SEND is TA recruitment and this is the picture nationally. We are constantly developing out TA learning and have really good agency staff in at the moment but we need our own. The salary range is set centrally and cannot be changed Q: (MM) Is the salary based on minimum wage or living wage?

SK: I'm not sure, I will check and feedback

C: (AP) It always comes down to funding

C: (SK) The priority now is making sure SEND get all of thew support they need

ACTION: SK to feedback to LGB re living wage or minimum wage for SEND TAs

MC & LW left the meeting at 18:18

12 SCHOOL RISK REGISTER

Failure to recruit remains the biggest risk

Q: (TL) How is the retention rate?

SK: The last academic year saw an unusually high number of staff leaving through retirement, promotion and staff leaving the profession altogether

Q: (AP) Is the trust giving flexibility to allow us to recruit as and when we need or do we have to follow a structure?

SK: We get a lot of support from HR for processes but we recruit as and when we need and support is given Trust wide

15.1 School Uniform Policy (MM)

MM raised concerns over the perceived lack of inclusion in the school uniform policy. SK assured it has been updated and approved at an earlier meeting, prior to MM joining the LGB and that MM would be included in the next review as early as possible. After discussions, it was discovered that although the policy is gender neutral when it comes to certain items of uniform, once the link has been followed to the supplier site it still states 'boys' and 'girls'. SK agreed to chat to the supplier to see if anything could be changed

ACTION: SK to contact school uniform supplier regarding gender based uniform items

ACTION: MM to meet with S Lazenby as and when the Uniform Policy is ready for the review process

15.2 Presentations of Lower Achieving Subjects (TL)

TL queried the possibility of inviting staff into present on the lower achieving subjects. SK agreed this was a good idea and it works well.
